Notice is hereby given that on **Friday December 18th, 2020**, the Board of Directors of the Starr County Groundwater Conservation District will hold a meeting at **10:00 a.m.** at the Starr County Courthouse Annex Conference Room #211, located at 100 N. FM 3167, Rio Grande City, Texas 78582.

An urgent public necessity exists requiring the Starr County Groundwater Conservation District to alter its meeting procedures due to COVID-19 pandemic. Notice is hereby given, as required by Texas Water Code section 36.108(e), that a meeting of the Starr County Groundwater Conservation District, comprised of its Board members. A quorum of the SCGCD board members may be present in person at the physical location or may participate via audio and video conference call. Likewise, members of the public may participate in person at the physical location or via audio or videoconference call. The meeting will be conducted pursuant to Texas Government Code, Sections 551.125, 551.127 and 551.131, and as modified by the Governor of Texas who ordered suspension of various provisions of the Open Meetings Act, Chapter 551, Government Code, effective March 16, 2020, in accordance with the Texas Disaster Act of 1975 (see the Governor's proclamation on March 13, 2020 as renewed, certifying that the COVID-19 pandemic poses an imminent threat of disaster and declaring a state of disaster for all counties in Texas).
